JOURNAL ARTICLE

- **Article:** Author Last name, first initial(s), Middle initial(s), (Year Published). Title of article. *Title of publication*, Volume (Issue), page range.

Example: Burkadze, Kh. (2021). The Legal Aspects of Artificial Intelligence Based on the EU Experience. *Law and World*, 7(5), pp. 8-13

- **Article in a Collection:** Author(s) Last name, first initial(s), Middle initial(s), (Year Published). Title of article. *Title of publication*, Volume (Issue), page range.

Example: Dhruvin N. D., Tarkesh J. M., & Vikash K. U. (2021). Constitutionality of Disaster Management Act, 2005 on the Touchstone of Federalism During Covid-19 in India. *Law and World*, 7(3), pp. 6-11

- **Article with an article number or DOI:** Author(s) Last name, first initial(s), Middle initial(s), (Year Published). Title of article. *Title of publication*, Volume (Issue), page range, Article number or DOI.

Example: Jerrentrup, A., Mueller, T., Glowalla, U., Herder, M., Henrichs, N., Neubauer, A., & Schaefer, J. R. (2018). Teaching medicine with the help of “Dr. House.” *PLOS ONE*, 13(3), Article e0193972.

BOOK

- **Book:** Author(s) Last name, first initial(s), Middle initial(s), (Year Published). Title of work (*Edition.*). Publisher. Page(s).

Example: Bailey S.D. and Daws S., (1998). The Procedure of the UN Security Council, (*3rd Edition.*). Oxford: Clarendon Press. p. 15.

- **E-book:** Author(s) Last name, first initial(s), Middle initial(s), (Year Published). Title of work (*Edition.*). Publisher. Page(s). Includes ISBN or DOI, or stable URL.

Example: Svendsen, S., & Løber, L. (2020). The big picture/Academic writing: The one-hour guide (*3rd digital ed.*). Hans Reitzel Forlag. pp. 15-16.

WEBSITE

- **Website with an author:** Author(s) Last Name, first initial(s), Middle initial(s), (Year, Month Day). *Title of web page or article*. Name of Website.: URL.: [Last access].

Example: Myers, S. L. (2007, May 18) *Estonia Accuses Russia of Computer Attacks*. New York Times. <<https://www.nytimes.com/2007/05/18/world/europe/18cnd-russia.html>> [Last access: 21 December, 2021].

- **Websites with no author:** Organization Name. (Year, Month Day). *Page title*. Site Name. URL.: [Last access].

Example: World Health Organization. (2018, May 24). *The top 10 causes of death*. National Institute of Mental Health. <<https://www.who.int/news-room/fact-sheets/detail/the-top-10-causes-of-death>> [Last access: 21 December, 2021].

LEGAL ACT

- **Code:** Name of Law (Year). *Title name*. Section number (paragraph.). URL.: [Last access].

Example: German Criminal Code (1998). *Negligent killing*. Section 222. federal Ministry of Justice. <https://www.gesetze-im-internet.de/englisch_stgb/englisch_stgb.html> [Last access: 21 December, 2021].

GOVERNMENT DOCUMENTS

- **Document:** Organization Name. (Year, Month Day). *Page title*. Site Name. URL.: [Last access].

Example: Occupational Safety and Health Administration. (2021, January 29). *Protecting workers: Guidance on mitigating and preventing the spread of COVID-19 in the workplace*. United States Department of Labor. <<https://www.osha.gov/coronavirus/safework>> [Last access: 21 December, 2021].
